WHEREAS, Article II section 7 (q), of the City Ordinance No. 60 s. 2016 generally known as The New Charter of Mabalacat City College, the Sangguniang Panlungsod of Mabalacat City empowers the Board of Trustees to exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

WHEREAS, because of the rapid adoption of Filipino users of various available social media sites, social media becomes the relevant platform for other educational institution to provide information, promote, advertise and showcase their institution to the public;

WHEREAS, the creation of the Communications and Events Unit is necessary in order for Mabalacat City College to have a dedicated unit in-charge of all creative, public relations, multi-media, advertising, information and other promotional needs of the College.

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby RESOLVED, by the Board of Trustees of MCC in its 5th Special Meeting herein assembled to approve the establishment of the COMMUNICATIONS AND EVENTS UNIT of Mabalacat City College under the supervision of the Office of the President.
