## RESOLUTION NO. 25 Series of 2020

### APPROVING THE PROCESSING OF APPLICANTS FOR PRESIDENT WITH INCOMPLETE CLEARANCES

**WHEREAS**, Article III Section 6 of the City Ordinance No. 60 s. 2016 generally known as **The New Charter of Mabalacat City College**, the *Sangguniang Panlungsod* empowers Mabalacat City College to exercise the general powers prescribed by this Ordinance in order to carry out and perform the powers and functions are hereby vested exclusively by the Board of Trustees;

**WHEREAS**, Article II section 7 (q), of the City Ordinance No. 60 s. 2016 generally known as **The New Charter of Mabalacat City College**, the *Sangguniang Panlungsod* of Mabalacat City empowers the Board of Trustees to exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

**WHEREAS**, based on the published and posted vacancy for MCC President, the following clearances shall be submitted not later than September 4, 2020, as extended by the Search Committee for President.

- Sandiganbayan
- Civil Service Commission (CSC)
- National Bureau of Investigation (NBI)
- Municipal/Regional Trial Court
- Ombudsman (for government employees)
- Institution/Company where applicant is presently employed





## MABALACAT CITY COLLEGE

**WHEREAS**, that none of the applicants have submitted the complete requirements on clearances due to the delay of the required government agencies to release the same on or before September 4, 2020.

**WHEREAS**, the Board of Trustees may decide on whether to accept the applications and continue the search process, under the condition that the applicant will submit an affidavit stating that he/she have no pending cases in the Sandiganbayan, Civil Service Commission, National Bureau of Investigation, Municipal/Regional Trial Court and Ombudsman, and that he/she will submit any proof of pending requests of clearances to the said government agencies.

**WHEREAS**, upon release of any of the pending clearances, it will be submitted to the Search Committee for President (SCP).

**WHEREAS**, failure to submit all clearances shall be a ground for disapproval/invalidation of application and appointment.

**NOW, THEREFORE, BE IT RESOLVED**, as it is hereby RESOLVED by the Board of Trustees, through its 3<sup>rd</sup> Quarter Meeting herein assembled to approve the Processing of Applicants for President with Incomplete Clearances.

**RESOLVED** further that a copy of this resolution be furnished to the Sangguniang Panlungsod of Mabalacat City, Pampanga and other concerned offices.
