order to carry out and perform the powers and functions are hereby vested exclusively by the Board of Trustees;

WHEREAS, Article II section 7 (q), of the City Ordinance No. 60 s. 2016 generally known as The New Charter of Mabalacat City College, the Sangguniang Panlungsod of Mabalacat City empowers the Board of Trustees to exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

WHEREAS, the Academic Council Meeting convened by the Vice President for Academic Affairs, Dr. Renato Dan A. Pablo II, together with the Institute Deans, and the Registrar to recommend the approval of an addendum of thirty-nine (39) graduates to the partial list of College graduates for Academic Year 2019-2020;

WHEREAS, Academic Council Resolution no.12 s. 2020 *a Resolution for the approval of the amendment of Academic council resolution no. 7 series 2020 (a Resolution for the Confirmation of the Partial list of College Graduates for the academic year 2019-2020)*;

WHEREAS, by further deliberation and evaluation of the Institute of Computing Studies and the College Registrar, has verified that MIKE MARQUEZ was not officially enrolled on the ITPRAC course during the Second Semester of Academic Year 2019 - 2020, hence is not qualified to be included in the list of graduates;
