**RESOLUTION NO. 02**

**APPROVING THE PHASING OUT OF GRADE 11 (SHS) PROGRAM IN MABALACAT CITY COLLEGE YEAR 2020-2021**

**WHEREAS**, Article III Section 6 of the City Ordinance No. 60 s. 2016 generally known as **The New Charter of Mabalacat City College**, the *Sangguniang Panlungsod* empowers Mabalacat City College to exercise the general powers prescribed by this Ordinance in order to carry out and perform the powers and functions are hereby vested exclusively by the Board of Trustees;

**WHEREAS**, Article II section 7 (q), of the City Ordinance No. 60 s. 2016 generally known as **The New Charter of Mabalacat City College**, the *Sangguniang Panlungsod* of Mabalacat City empowers the Board of Trustees to exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

**WHEREAS**, in a joint academic meeting of the Office of the Vice president for Research and Extension Services, Office of the Vice President for Academic Affairs and the Office of the Senior High School Director, recommends the phasing out of Grade 11 program in Mabalacat City College – Dolores and Dapdap this A. Y. 2020-2021.

**WHEREAS**, **CHED Memo Order No. 33 series of 2015 – B. Parameters of LUCs in SHS No. 2 – School years of operation** states that, as the LUCs are created and mandated primarily to provide technical-vocational and other similar post-secondary programs, their engagement in basic education through Senior High-School shall be limited to the K to 12 transition period only, from SY 2016-2017 to 2020-2021.
