Mabalacat City empowers the Board of Trustees to exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

**WHEREAS**, in the Academic Council Meeting convened on September 2, 2021 by the Vice President for Academic Affairs, Dr. Melanie V. Briones, and attended by the members of the Academic Council, the Academic Council unanimously recommended in its Resolution No. 17 series of 2021, the approval of the Merging of Institute of Business Education (IBE) and Institute of Computing Studies (ICS) stating its rationale:

WHEREAS, the business sector [through] its human capital, particularly the brains of organization, decide as to which technological tool should be invented and as to how will this be introduced and marketed to the consumers;

WHEREAS, programming and technological innovations are closely correlated with economy and business utilizes such tools to improve operations;

WHEREAS, business now dictates computer programming and digitization.

**BE IT RESOLVED**, That the Board of Trustees of Mabalacat City College ratifies the said recommendation of the Academic Council in its RESOLUTION NO. 17 - "*RESOLUTION APPROVING THE MERGING OF INSTITUTE OF BUSINESS EDUCATION (IBE) AND INSTITUTE OF COMPUTING STUDIES (ICS)*", with the amendment of the name of the merged institute to **Institute of Business and Computing Education (IBCE**);
