WHEREAS, the Board on May 16, 2013 passed Resolution No. 18 s. 2013 - A Resolution Authorizing the Collection of Updated Miscellaneous and Other Fees;

WHEREAS, there is a need to update the amounts specified in the Schedule of Tuition and other Authorized Fees, considering the upgraded facilities, enhanced laboratories and simulation rooms, and improved services since 2013;

BE IT RESOLVED, That the Board of Trustees of Mabalacat City College amends Resolution No. 18 s. 2013 - Authorizing the Collection of Updated Miscellaneous and Other Fees, to be as follows:
