RATIFICATION OF ACADEMIC RESOLUTION NO. 15 - "APPROVING THE MCCPLUS: FULL ONLINE MODE OF COURSE DELIVERY AND DIGI HUBS PLUS FOR ACADEMIC YEAR 2021 - 2022"

WHEREAS, Article III Section 6 of the City Ordinance No. 60 s. 2016 generally known as The New Charter of Mabalacat City College, the Sangguniang Panlungsod empowers Mabalacat City College to exercise the general powers prescribed by this Ordinance in order to carry out and perform the powers and functions are hereby vested exclusively by the Board of Trustees;

WHEREAS, Article II section 7 (q), of the City Ordinance No. 60 s. 2016 generally known as The New Charter of Mabalacat City College, the Sangguniang Panlungsod of Mabalacat City empowers the Board of Trustees to exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

WHEREAS, in the Academic Council Meeting convened on August 17 2021 by the Vice President for Academic Affairs, Dr. Melanie V. Briones, and attended by the members of the Academic Council, the Academic Council unanimously recommended in its Resolution No. 15 series of 2021, the approval of the MCC Plus: Full Online Mode of Course Delivery and Digi Hubs Plus for Academic Year 2021 - 2022, stating its rationale:

WHEREAS, the COVID-19 continuously spreads and produces several variants; hence stricter alternative working arrangements have been implemented and the safety of both the faculty and students are of primary concern of MCC;

WHEREAS, MCC, being under the local government of Mabalacat City, has proven that the public sector is not losing ground as it continuous to expand in terms of quality education; hence, the institution going to enhance its flexible learning mode which took effect during the AY2020-2021 into a full online course delivery;

WHEREAS, MCC Plus bears its background, readiness and capacity to implement, delivery of instruction into full online mode, grading, technical support and academic services;

WHEREAS, the MCC Plus shall have two (areas) of focus: Full Online Course Delivery; and Transformation of DigiHubs into DigiHubs Plus;

WHEREAS, the delivery of instruction under the MCC Plus will allow learning experiences of its students using various devices such as smartphones and computers with internet support in sychronous and asynchos approaches;

BE IT RESOLVED, That the Board of Trustees of Mabalacat City College ratifies the said recommendation of the Academic Council in its RESOLUTION NO. 15 - "*APPROVING THE MCC PLUS: FULL ONLINE MODE OF COURSE DELIVERY AND DIGI HUBS PLUS FOR ACADEMIC YEAR 2021 - 2022*";
