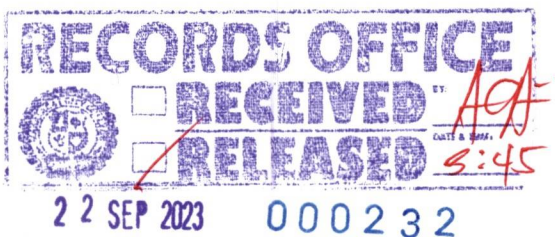

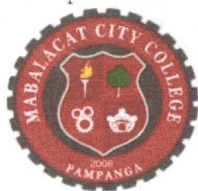

# MABALACAT CITY COLLEGE

**WHEREAS**, Article III Section 6 of the City Ordinance No. 60 s. 2016 otherwise known as The New Charter of Mabalacat City College, provides that the carrying out and performance of the general powers and functions of Mabalacat City College are vested exclusively [in] the Board of Trustees;

**WHEREAS**, Article II section 7 (q) of the New Charter of Mabalacat City College provides that the Board of Trustees shall exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

**WHEREAS**, Mabalacat City College received a letter of invitation on February 23, 2023 from Beijing Pihua International Education Technology Co., inviting the institution to participate in the China Study Abroad Forum (CSAF), which took place in Beijing, China, on April 6, 2023 to April 9, 2023;

**WHEREAS**, In accordance with Office of the President of the Philippines Memorandum Circular No. 35 Section 5(b), individuals under contract of service may be issued with foreign travel authority and trip expenses for highly meritorious circumstances requiring highly technical and specialized skills;

**WHEREAS**, As the College President, Dr. Michelle Aguilar-Ong is the proper and most qualified representative to participate in the China Study Abroad Forum (CSAF) for Mabalacat City College;

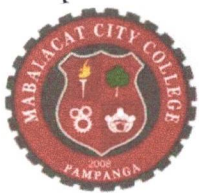
**WHEREAS**, The accommodations, local transportation expenses, health insurance and other allowances will be funded by Mabalacat City College;

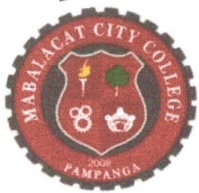
