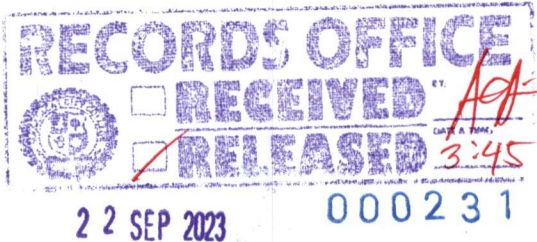

WHEREAS, Mabalacat City College was the only Local College invited to join the conference among the one hundred three (103) Local University and Colleges (LUCs) in the Philippines;

WHEREAS, Mabalacat City College was invited to discover emerging trends in student mobility, establish new partnerships, participate in networking opportunities, and identify upcoming marketplace needs;

WHEREAS, Mabalacat City College, thru the Board of Trustees decided to give a Grant to the most qualified person to represent the institution in the National Association of Foreign Student Advisers (NAFSA): Association of International Educators 2023 Annual Conference and Expo in Washington, D.C.;

WHEREAS, the Grant will include roundtrip airfare, accommodations, local transportation expenses, health insurance, and other allowances which will be funded by Mabalacat City College;

WHEREAS, the College President, Dr. Michelle Aguilar-Ong is deemed to be the proper and most qualified representative to represent the institution in the National Association of Foreign Student Advisers (NAFSA): Association of International Educators 2023 Annual Conference and Expo in Washington, D.C.;



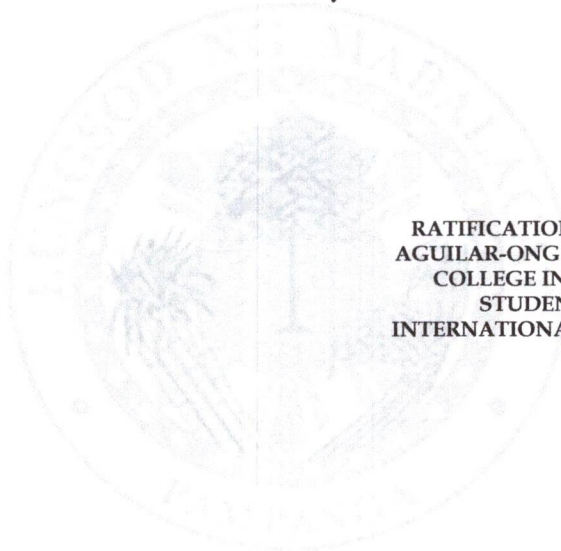
