## BOARD OF TRUSTEES

**WHEREAS**, Article III Section 6 of the City Ordinance No. 60 s. 2016 otherwise known as The New Charter of Mabalacat City College, provides that the carrying out and performance of the general powers and functions of Mabalacat City College are vested exclusively [in] the Board of Trustees;

**WHEREAS**, Article II section 7 (q) of the New Charter of Mabalacat City College provides that the Board of Trustees shall exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

**WHEREAS**, in the Academic Council Meeting convened on March 30, 2023 by the Assistant Vice President for Academic Affairs, Dr. Romeo D. Erese III and was attended by the members of the Academic Council, Registrar Head, and Director for Research Innovations. The Academic Council unanimously recommended the Zero-Based Grading System in its Resolution No. 06, series of 2023 - "Approving the Zero-Based Grading System";

**WHEREAS**, currently, MCC uses a fifty-based grading system;

**WHEREAS**, MCC pushes for a zero-based grading system, a stricter grading system that will challenge students to accomplish their tasks competently. This makes the students' progress transparent and compels them to perform at their maximum potential;

**WHEREAS**, MCC benchmarks the standards of De La Salle University and Ateneo De Manila University, top-ranked universities in the Philippines that use the Zero-based grading system;

**WHEREAS**, MCC adheres to the highest quality standards; hence the grading system should oblige students to value their academic performance, which will be reflected in their grades. This is subject to the approval of the College President and Board of Trustees to make students responsible for their academic commitments;

**WHEREAS**, the adoption of the zero-based grading system shall take effect this Academic Year 2023-2024 for the incoming freshmen.

**BE IT RESOLVED**, that the Board of Trustees of Mabalacat City College approves the said recommendation of the Academic Council in its RESOLUTION NO. 06, series of 2023 - "Approving the Zero-Based Grading System";

**RESOLVED FURTHER**, that the contents of Academic Council Resolution No. 06, series of 2023 shall form part of this resolution;

**RESOLVED FINALLY**, that a copy of this resolution be furnished to the offices concerned.


