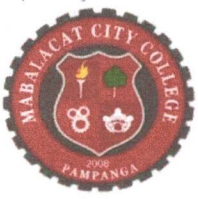

WHEREAS, Article III Section 6 of the City Ordinance No. 60 s. 2016 otherwise known as The New Charter of Mabalacat City College, provides that the carrying out and performance of the general powers and functions of Mabalacat City College are vested exclusively [in] the Board of Trustees;

WHEREAS, Article II section 7 (q) of the New Charter of Mabalacat City College provides that the Board of Trustees shall exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

WHEREAS, on July 10, 2023, Mabalacat City College, through the College President, received an invitation to join the Workshop and Exhibit on the China ASEAN Education Cooperation Week on August 27, 2023 to September 9, 2023 in Beijing, China.

WHEREAS, Mabalacat City College President signed a Memorandum of Understanding with Shijiazhuang Institute of Railway Technology, China on September 7, 2023.

WHEREAS, In accordance with Office of the President of the Philippines Memorandum Circular No. 35 Section 5(b), individuals under contract of service may be issued with foreign travel authority and trip expenses for highly meritorious circumstances requiring highly technical and specialized skills;

WHEREAS, the College President, Dr. Michelle Aguilar-Ong is the proper and most qualified representative to represent the institution in the Workshop and Exhibit on the China ASEAN Education Cooperation Week in Beijing, China;

WHEREAS, The roundtrip airfare, accommodations, local transportation expenses, health insurance and other allowances will be funded by Mabalacat City College;

BE IT RESOLVED, That the Board of Trustees of Mabalacat City College authorizes the College President, Dr. Michelle Aguilar-Ong to be the representative of Mabalacat City College in the Workshop and Exhibit on the China ASEAN Education Cooperation Week in Beijing, China and approves the funding of the said expenses for the said event subject to pertinent government budget and accounting rules and laws;

RESOLVED FINALLY, that a copy of these resolutions be furnished to the offices concerned.
