WHEREAS, Article III Section 6 of the City Ordinance No. 60 s. 2016 otherwise known as The New Charter of Mabalacat City College, provides that the carrying out and performance of the general powers and functions of Mabalacat City College (MCC) are vested exclusively [in] the Board of Trustees;

WHEREAS, Article II section 7 (q) of the New Charter of Mabalacat City College provides that the Board of Trustees shall exercise and perform such other powers and functions not inconsistent with existing law or ordinance as it may deem necessary for the effective and efficient governance of the College;

WHEREAS, Mabalacat City College President, Dr. Aguilar-Ong, is the recipient of the Continuing Professional Development Studies Grant (CPDSG) to undertake and complete a short-term program in British Columbia Institute of Technology from November 29 to December 16, 2023 at Vancouver, Canada. The short-term is for Trainers on Curriculum Development, specializing on Transportation;

WHEREAS, the College President, Dr. Michelle Aguilar-Ong, is the proper and most qualified representative to represent the institution in the said short term program;

WHEREAS, the Office of the President of the Philippines Memorandum Circular No. 35 Section 5(b) provides that individuals under contract of service may be issued with foreign travel authority and trip expenses for highly meritorious circumstances requiring highly technical and specialized skills;

WHEREAS, in accordance with the aforementioned memorandum, the roundtrip airfare, accommodations, local transportation expenses, health insurance and other allowances will be funded by Mabalacat City College, relative to the said event and for that purpose;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED that the board of Trustees of Mabalacat City College authorizes the College President, Dr. Michelle Aguilar-Ong, to be the representative of the institution in the Continuing Professional Development Studies Grant (CPDSG) to undertake and complete a short-term program in British Columbia Institute of Technology from November 29 to December 16, 2023 at Vancouver, Canada and approves the funding of the relevant travel, accommodation and incidental expenses on the said event and for that purpose, subject to the availability of pertinent government budget and accounting rules and regulations;
