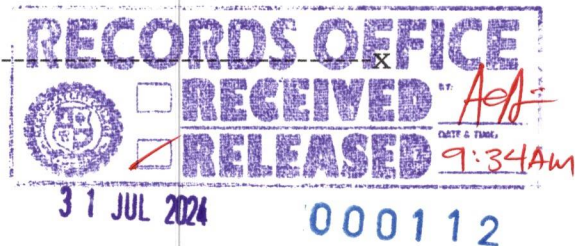

**APPROVING THE MEMBERS OF THE SEARCH COMMITTEE FOR
PRESIDENT (SCP) OF MABALACAT CITY COLLEGE**

WHEREAS, Article III Section 6 of the City Ordinance No. 60 s. 2016 otherwise known as The New Charter of Mabalacat City College, provides that the carrying out and performance of the general powers and functions of Mabalacat City College (MCC) are vested exclusively [in] the Board of Trustees;

WHEREAS, Article II section 7 (o), of the City Ordinance No. 60 s. 2016 generally known as The New Charter of Mabalacat City College, the Sangguniang Panlungsod of Mabalacat City empowers the Board of Trustees to prescribe implementing rules and regulation for the administration and management of the College;

WHEREAS, based from CMO No. 18 series of 2022 Article IV Section 12 states that the SCP shall have at least five (5) members selected by the Board composed

of qualified representatives from the academic community, the private sector, CHED, Association of Local Universities and Colleges (ALCU) if the institution is a member of said organization, and other relevant government agencies as may be identified by the GB. The GB shall designate the Chairperson of the SCP from among the members of the SCP. The SCP shall meet within fifteen days from its constitution;

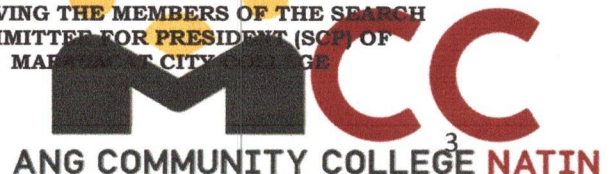
