Panlungsod empowers Mabalacat City College to exercise the general powers





prescribed by this Ordinance in order to carry out and perform the powers and functions are hereby vested exclusively by the Board of Trustees;

**WHEREAS**, Article II section 7 (q), of the City Ordinance No. 60 s. 2016 generally known as The New Charter of Mabalacat City College, the Sangguniang Panlungsod of Mabalacat City empowers the Board of Trustees to confer degrees, diploma and certificates of completion, upon the recommendation of the academic council, to candidates for graduation who fully complied with the requirements set forth in their respective programs of studies;

**WHEREAS**, a Special Academic Council Meeting was convened by the Officer-in-Charge Vice President for Academic Affairs, Ms. Marilyn Arcilla, and attended by the Academic Council members and Office of the Registrar in line with the discussed resolution approving the official list of graduands and academic awardees for the academic year 2024-2025.

**WHEREAS**, the deliberation for the graduating students of Mabalacat City College for the academic year 2024-2025 was conducted on July 14, 2025 at MB 102, in the presence of the Registrar, the OIC Vice President for Academic Affairs, Deans and Program Heads.

**WHEREAS**, the deliberation included a thorough review and verification of the academic records and achievements of all candidates for graduation.

**WHEREAS**, the list of Latin awardees was finalized during the deliberation held on July 14, 2025.

**WHEREAS**, it is the responsibility of the institution to ensure that the list of the graduands and of the academic awardees are accurate, complete and reflective of the students' academic performance and achievements.

**WHEREAS**, there is a total of **729** college graduates for the academic year 2024-2025.

**WHEREAS**, the Institute of Arts and Sciences (IAS) has **37** graduates, the Institute of Business and Computing Education (IBCE) has **271** graduates, the Institute of Hospitality and Tourism Management (IHTM) has **110** graduates and the Institute of Teacher Education (ITE) has **311** graduates.

**WHEREAS**, from among the **729** graduates from both campuses, there are **249** Academic Awardees.

**WHEREAS**, the members of the Academic Council unanimously approved the Resolution No. 5 Series of 2025 as presented;
