WHEREAS, on December 29, 2022 the Commission on Higher Education (CHED) issued the CHED Memorandum Order No. 18 s. 2022 prescribing the Policies Standards and Guidelines on the Grant of Institutional Recognition as a Higher Education Institution to Local Universities and Colleges (LUCs;)

WHEREAS Article II, Section 8 of CHED Memorandum Order No. 18, Series of 2022 prescribes the required composition of the Governing Board for Local Universities and Colleges (LUCs), which must include but not be limited to the following representatives:

- a. Chairperson Local Chief Executive (LGU)
- b. Vice Chairperson University/College President (LUC)
- c. SP Chair of the Committee on Education
- d. President of duly recognized Faculty Association
- e. President of duly recognized Alumni Association
- f. President of duly recognized Supreme Student Council
- g. Representative from Department of Science and Technology or Department Agriculture depending on the focus of the LUCs
- h. Representative from CHED who shall be a permanent resource person Shall be designated by the CHED Chairperson
- i. Representative from NEDA may be invited as a resource person.

WHEREAS, pursuant to CMO No. 18, Series of 2022 Mabalacat City College is mandated to comply in order to secure CHED Institutional Recognition and thereby qualify as a regulated Public Higher Education Institution;

NOW, THEREFORE, BE IT RESOLVED as it is hereby **RESOLVED**, by the Board of Trustees of MCC in its 2nd Regular Meeting herein assembled, to approve, as it is hereby approved, *The ADOPTATION OF CHED MEMORANDUM NO. 18 Series of 2022 Article II, Section 8 ENTITLED: Policies, Standards and Guidelines on the Grant of Institutional Recognition as a Higher Education Institution to Local Universities and Colleges (LUCs)*
