WHEREAS, there is a need to designate signatory for the MCC related documents to ensure the efficient and effective administration of the College’s institutional affairs;


WHEREAS, the MCC Board of Trustees recognizes the authority and responsibility of the College President to oversee financial transactions and institutional operations;





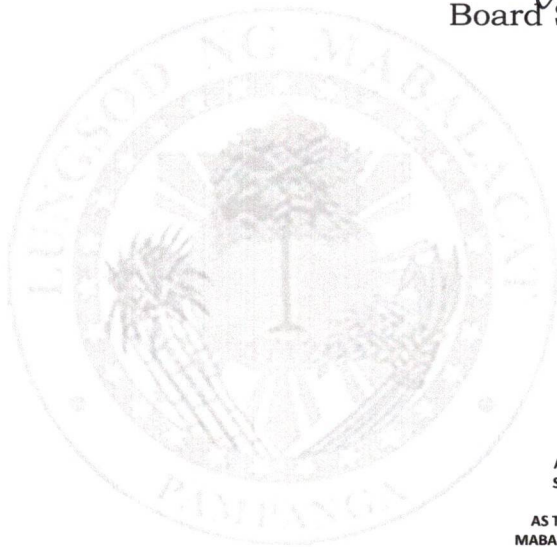
