

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is executed and entered this 14th day of September 2023, at Mabalacat City, Pampanga, by and between:

DAPDAP ELEMENTARY SCHOOL, of the City of Mabalacat herein represented by School Principal, **Richard A. Broñola** hereinafter referred to as the **"FIRST PARTY"**;

And

MABALACAT CITY COLLEGE (MCC Dapdap Campus), an institution of higher learning owned and operated by the local government of Mabalacat City established on October 4, 2007, by virtue of Municipal Ordinance No. 2, series of 2007 and herein represented by the Institute Dean, **Dr. Arvina D. Sarmiento** with office address at Rizal St., Dolores, Mabalacat City, Pampanga, hereinafter referred to as the **"SECOND PARTY"**;

WITNESSETH

WHEREAS, this agreement sets forth the obligations of the parties and affirms that the parties hereto shall cooperate and exert all efforts to realize the Community Empowerment Programs/Projects/Activities of the SECOND PARTY and faithfully undertake their respective responsibilities agreed hereunder;

WHEREAS, the purpose and intent of this Memorandum of Agreement is the implementation of the **Community Empowerment Services of the College**;

WHEREAS, the **SECOND PARTY** has presented Programs/Projects/Activities to the **FIRST PARTY**, to be implemented at the premises of the FIRST PARTY for five (5) academic years AY. 2023-2028;

WHEREAS, the project includes literacy development, environmental protection efforts, cultural preservation, and livelihood programs for the community.

WHEREAS, the FIST PARTY has accepted the project proposal.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties herein agree:

1. RESPONSIBILITIES OF THE FIRST PARTY

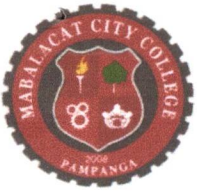
- 1.1 Accept and allow groups assigned to work on designated areas within Dapdap Elementary School, Mabalacat City;
- 1.2 Assist MCC student and faculty volunteers during ocular inspection of FIRST PARTY's premises, and ensure their security and safety;
- 1.3 Provide baseline data for the programs/projects/activities;
- 1.4 Provide information on existing programs/projects/activities to be implemented;
- 1.5 Assist MCC student and faculty volunteers in implementing the programs/projects/activities;

- 1.6 Provide assistance needed for the programs/projects/activities (e.g. venue, equipment, etc.);
- 1.7 Provide certification to implemented programs/projects/activities; and
- 1.8 Periodically evaluate programs/projects/activities.

2. RESPONSIBILITY OF THE SECOND PARTY

- 2.1 Adopt the Barangay for community organization and development;
- 2.2 Conduct ocular inspection for familiarization of the place;
- 2.3 Request baseline data for programming purposes;
- 2.4 Implement programs/projects/activities for the community in accordance with its approved project proposals;
- 2.5 Provide written reports for filing purposes;
- 2.6 Request certification for every project; and
- 2.7 Periodically evaluate the programs/projects/activities.

3. CONFIDENTIALITY AND DATA PRIVACY

The Parties shall perform their respective obligations with due regard for confidentiality and data privacy laws, rules, and regulations.

4. TERM AND SCOPE

- 4.1 This Memorandum of Agreement shall be effective for five 5 years from the execution of this Agreement unless terminated by anyone of the parties, for cause, and shall take effect immediately upon signing of the parties;
- 4.2 This Agreement may, at any time during its period of validity, be terminated by the FIRST PARTY and/or SECOND PARTY, for cause, upon prior notice to the other party, at least one month before the termination date; and

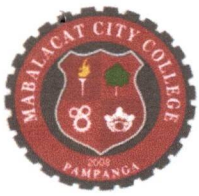
